NOTIFICATION

The 18th July, 2025

S.R.O.No.537/2025— In compliance to the direction of the Hon'ble Supreme Court of India in W.P (C) No. 643 of 2015 in the judgement dated 4th January, 2024 (All India Judges Versus Union of India & Ors) and accepting the recommendations of the Second National Judicial Pay Commission (SNJPC), the State Government in consultation with the Committee for Service Conditions of the District Judiciary (CSCDJ) of the High Court of Orissa do hereby make the following orders further to amend the Odisha Judicial Officers (Medical Attendance) Order, 2013 namely:-

1. Short title and commencement

- (1) These orders may be called the Odisha Judicial Officers (Medical Attendance) (Amendment) Order, 2025.
- (2) They shall come into force with effect from the date of issue of these orders.
- **2.** In the Odisha Judicial Officers (Medical Attendance) Order, 2013, the provisions of sub-clause (v) of Clause 2 shall be substituted with the followings;
- (v)"Members of the family" means spouse and dependants i.e. father, mother, unmarried son or step-son, unmarried or widowed or divorced daughter or step-daughter of the judicial officer and in case of female judicial officer, in addition to the above her dependant father-in-law and mother-in-law.

Note: A person to be considered as a dependant, other than the spouse of the judicial officer, his total income from all sources (other than pension/ family pension relating to the judicial officer concerned) must not exceed Rs.50,000/- (Fifty Thousand) per month.

The spouse or other dependants of judicial officers drawing family pension of the judicial officer concerned shall also be eligible for medical facilities/ reimbursement at par with the pensioners of the judiciary.

Explanation: In order to verify the monthly income of the dependant pensioner, a self declaration to be filed by the applicant along with the application shall be sufficient proof for the purpose of this order."

- **3.** In the Odisha Judicial Officers (Medical Attendance) Order, 2013, the provisions of Clause 6 shall be substituted with the followings;
 - "6. General Treatment/Special treatment in certain cases:- (a) The necessity of reference from the Medical Officer of a Government hospital for treatment inside or outside the State shall be dispensed with. Straight away, the Judicial Officers including pensioners/family pensioners and their members of family shall be entitled to have consultations/treatment in the Government notified/empanelled private hospitals/Pathological Labs and any other hospital / nursing home/diagnostic centre/medical institute/medical clinic/medical centre whether Allopathic, Ayurvedic, Unani or Homoeopathic and seek reimbursement by submitting the bills.
 - (b) The Principal District Judges or Registry of High Court [in respect of Principal District Judge] or the Controlling Officers/Heads of the Department (in case of Officers on deputation / officers incharge of independent establishment) shall be empowered to address credit letters to the concerned hospitals where the Judicial Officer or Pensioner/Family Pensioner and members of their family has been or to be admitted as inpatient.
 - (c) For the Judicial Officers /Pensioners/ Family Pensioners and members of their family, a cashless group health insurance card of rupees ten lakh per annum shall be issued by the Registry of the High Court on payment of premium from the RCM head of account. The Registry of the High Court with approval of the CSCDJ shall select the Insurance Company in a transparent procedure to provide such cashless health insurance services.
 - (d) To meet the expenditure of treatment, the Judicial Officers /Pensioners/ Family Pensioners for the self or members of their family should first opt to avail the cashless health insurance facility depending on the amount of expenditure or may also opt for full reimbursement of the treatment expenditure by submitting bills to the Principal District Judges or other authorized Officer of that rank or the Controlling Officers/Heads of the Department (in case of Officers on deputation/ officers incharge of independent establishment) or as the case may be by the Registry of the High Courts. In case the quantum of cashless

health insurance is not sufficient to meet the expenditure, the amount paid over and above the amount of health insurance shall be reimbursed in usual process on submission of bills.

(e) The State Government in Finance Department shall make sufficient budgetary provisions for the purpose in every financial year. If required funds shall be made available by making supplementary provisions or on re-appropriation of funds by the State government.

To avoid delays in processing and sanctioning the bills for want of funds, the Registry of High court shall take prompt action in addressing the Government for releasing additional funds and the Finance Department of the State shall take immediate action by way of making available the additional funds to the High Court on this account.

- (f) The expenditure incurred towards inpatient treatment or for serious ailments requiring more or less continuous treatment shall be processed and sanctioned by the Principal District Judges or other authorized Officer of that rank or the Controlling Officers/Heads of the Department (in case of Officers on deputation /Officers in-charge of independent establishment) oras the case may be by the Registry of the High Courts.
- (g) In the case of emergency, the Judicial Officer, serving & retired as well as the family pensioner and their members of family can take treatment in any private hospitals inside or outside the State – not necessarily, Government notified hospitals and seek reimbursement as per the usual procedure. If necessary, Credit letter shall be issued for the purpose.
- (h) The retired Judicial Officers/family pensioners and their members of family who have settled down in another State shall have the facility to claim medical reimbursement/advance from the State from which she/he is drawing pension/family pension.
- (i) The cost of treatment including room charges/tests undergone in any Government/Government notified/recognized hospitals/pathological labs in an emergency or otherwise shall be reimbursed to the serving officers on tour (official or private purpose) to another State or settled in another State after retirement even though it is not recognized hospital/lab in the State in which the officer is serving or had served.

- **4.** In the Odisha Judicial Officers (Medical Attendance) Order, 2013, the provisions of Clause 7 shall be substituted with the followings;
 - "7. The District Judge of the place where the Judicial Officer /retired Judicial Officer/family pensioner and members of their family resides is authorised to sanction the reimbursement of expenses incurred by the Judicial Officers/retired Judicial Officer and members of their family. In case of Judicial Officers on deputation either to any department of government or to the High Court, the Controlling Officers or the concerned Registrar of the High Court as the case may be is authorised to sanction the reimbursement of expenses incurred by the Judicial Officers and members of their family. The bills shall be cleared within a maximum period of two month from the date of receipt.
- **5.** In the Odisha Judicial Officers (Medical Attendance) Order, 2013, the provisions of Clause 9 shall be substituted with the followings;
 - "9. Judicial Officers/retired Judicial Officers/family pensioners and members of their family shall be entitled to advance to meet the medical expenses for treatment. On submission of the estimate given by the recognized/empanelled hospital or any other hospital where the patient is proposed to be treated, 80% of the estimate amount shall be sanctioned as advance, subject to preliminary scrutiny by the Principal District Judge or a District Judge of equivalent rank authorized by the Registry of the High Court or the Controlling Officers/Heads of the Department (in case of Officers on deputation/ Officers in-charge of independent establishment) The balance shall be reimbursed on certification by the designated Civil Surgeon or Official of the Directorate of Medical & Health Services as the case may be. If the Government approved rates are not available for any particular item, the certifying officer shall have due regard to the rates generally charged in the hospitals concerned. Though there needs to be scrutiny before sanctioning the final payment in view of the tendency to exaggerate the estimates, the extent of disallowance shall be minimal and the reasons for disallowance shall be disclosed by the certifying authority. The bills sent by the District Judge/ Registry of the High Court/the Controlling Officers/Heads of the Department (in case of Officers on deputation/ Officers in-charge of independent establishment) for scrutiny of the designated Civil Surgeon/Officer of Directorate shall be cleared within a maximum period of one month from the date of receipt.

- **6**. In the Odisha Judicial Officers (Medical Attendance) Order, 2013, the provisions of Clause 10 including *Annexure-I* shall be substituted with the followings;
 - **"10.** For medical treatment of Judicial Officers/Pensioners/Family Pensioners and members of their family, the hospitals/institutions in India are hereby recognized and notified as in *Annexure-I*.
