1. Applications in the prescribed format are invited from the eligible candidates for direct recruitment from the Bar in the cadre of District Judge in the Scale of Pay of Rs.1,44,840 – 1,94,660 /- with usual Dearness Allowance and other Allowances as admissible from time to time.
2. **VACANCY POSITION:** Total vacancy-25 (UR-12, SC-04, ST-06 and SEBC-03). The category wise vacancy position along with reservation thereof is provided in the detailed advertisement available in the Court's website.
3. **AGE:** A candidate must not be below 35 years of age and above 45 years of age as on 1st April, 2022. Candidates claiming age relaxation and reservation benefits will be as per government rules prescribed for the purpose.


