A list of the candidates who qualify in the Computer Application Test will be declared at the examination centre by 02.00 P.M. and will also be published on the Court's website. Those candidates who shall qualify in the Computer Application Test shall appear in the Skill Test (Short Hand & Type Writing Test) on the same day i.e. on 09.12.2023 at the same venue. No separate admit card will be issued for appearing in the Skill Test (Short Hand & Type Writing Test). The candidates are to come prepared accordingly.

Further, the verification of certificates/ testimonials of the candidates will be done 02.00 P.M. onwards of 09.12.2023.

The candidates are to bring the following original certificates/ testimonials alongwith self attested photocopies thereof.

- **1.** (i) Print Copy of the online application form.
  - (ii) HSC or equivalent certificate in support of age.
  - (iii) Certificate of Bachelors degree from a recognised University or such other qualification equivalent thereto.
  - (iv) Certificate showing adequate knowledge in Computer Application.
  - (v) Certificate from a recognised institute showing a minimum speed of 80 words per minute in Short Hand and 40 words per minute in Type Writing.
  - (vi) Certificate of good character from the Institution last attended, or from two persons of repute, one of whom must be a Gazetted Officer.
  - (vii) One recent passport size photograph alongwith original Aadhaar card.
  - (viii) Certificates from the competent authority indicating the category of the caste or the tribe or the class of the applicant, in case he or she belongs to the Scheduled Caste, Scheduled Tribe or SEBC who claims age relaxation and reservation under such category.
  - (ix) Medical Certificate or Disability Certificate from the competent Medical Board or Authority indicating the nature of disability in case of PwD to claim age relaxation and reservation under such category.
  - (x) Candidates claiming reservation under Ex-serviceman category are to bring Discharge Certificate issued by the Commanding officer of the Unit last served. They must also submit an affidavit that they are not

been appointed against any civil post after Military Service, wherever applicable.

- (xi) Sports certificate, issued from the Director of Sports, Odisha, if the candidate claims reservation under such category.
- (xii) NOC/ letter of permission from the Competent Authority for candidates working in Government offices.
