The candidates are required to bring with themselves the following documents along with original certificates, the copies of which have been uploaded by them at the time of submission of Online Application for verification on 17.02.2024 :-

1. e-Admit Card of Viva-Voce Test.
2. Print out of Online Application Form along with self-attested copies of certificates uploaded during submission of the Online Application.

3. Three Passport Size colour photographs.


Documents to be produced in Original

1. Aadhaar Card.
2. HSC or equivalent certificate in support of proof of age.
3. Certificate of Bachelor's Degree from a recognised University or such other qualification equivalent thereto.
4. Certificate showing adequate knowledge in Computer Application.
5. Certificate of good character from the Institution last attended, or from two persons of repute, one of whom must be a Gazetted Officer.
6. Caste (ST) Certificate.
7. Discharge Certificate and Affidavit (in case of Ex-Servicemen).
8. Medical Certificate or Disability Certificate (in case of PwD).
9. Sports Certificate (in case of Sports Person).
10. NOC (wherever applicable)
11. Service Certificate in case of Group-"C" and Group-"D" employees of the High Court of Orissa.

Production of Aadhaar Card as the proof of identity is mandatory. Therefore, candidates are to bring the e-Admit Card of Viva-Voce Test and original Aadhaar Card compulsorily in order to appear in the Viva-Voce Test.

The candidates are advised to visit the Court's website regularly for information about the result and other updates in connection with this recruitment examination.




