The result of the Computer Application Test will be published on the same day by 12.00 noon in the Court's Notice Board and Website. Those candidates who qualify in the Computer Application Test are to appear in the Viva-Voce Test which will be held on **05.05.2024** at the First Floor of the New Building of the Court from **2.00 P.M.** onwards. - 6. Certificate from competent authority indicating the category of the Caste or the Tribe or the Class of the applicant. (Wherever Applicable)
- 7. Discharge Certificate and Affidavit (in case of Ex-Servicemen).
- 8. Medical Certificate or Disability Certificate (in case of PwD).
- Copy of publication of Changed name/Surname in local leading daily newspaper as well as copy of notification in the Odisha Gazzette. (wherever Applicable)
- 10. NOC (in case of Government Servant)
- 11. Service Certificate in case of Group-"C" and Group-"D" employees of the High Court of Orissa.

Production of Aadhaar Card as the proof of identity is mandatory. Therefore, candidates are to bring the e-Admit Card of Computer Application Test and original Aadhaar Card compulsorily in order to appear in the Viva-Voce Test.
