REPORT BY THE AMICUS CURIAE DATED 19.03.2021

- 1. That in order to ensure that the Olive Ridley Turtles are protected within the Gahirmatha Sanctuary and Rushikulya area, this Hon'ble Court vide order dtd.15.03.2021 has passed a series of directions, including the direction to strictly enforce the fishing ban within the prohibited areas.
- 2. That in the night of 15.03.2021, when a patrolling team of the Gahirmath Wildlife Range and the APR police staff were patrolling the Gahirmatha Marine Sanctuary area, at about 10:30 pm they detected a fishing trawler in the Sanctuary area. When the said trawler was attempted to be intercepted and captured, the crew members of the trawler attacked the patrolling staff with sharp weapons and as a result five nos. of patrolling staff sustained injuries. Thereafter the said trawler called upon about 10 further trawlers and all such trawlers



ganged up to drown the patrolling boat alongwith the patrolling staff. In the circumstances, the patrolling boat has been badly damaged (<u>Annexure 1</u>) and injuries have been caused to the staff. As per the staff version, they have narrowly escaped death on the high seas.

- A FIR to this effect has been given at the Talchua Marine PS on 16.03.2021 (<u>Annexure 2</u>). A report dtd.17.03.2021 (<u>Annexure</u> <u>3</u>) has been forwarded by the DFO, Mangrove Forest Division (Wildlife) Rajnagar, to the Regional Chief Conservator of Forests, Bhubaneswar.
- 4. It is seen from the FIR and the report dtd.17.03.2021, that the accused person and his family are habitual offenders and atleast 11 cases are pending against them. However it is baffling that the accused persons are not being arrested and/or are being released on bail. Even the offending boats are being released during the fishing ban period.
- 5. Till the evening on 18.03.2021, none of the accused persons or their associates have been arrested, nor the offending boat has been traced. This has severely affected the morale of the patrolling staff and does not send a good signal to other offenders in the present nesting season. Hence it is requested that the Hon'ble Court may consider the following suggestions:
 - a. The Home Department, Government of Odisha, be directed to provide additional sections of armed police force to the three marine police stations i.e. Talchua, Tantiapal and Jamboo, within 48 hours.






- b. The Superintendent of Police, Kendrapara, be directed to supervise the investigation of Talchua Marine PS Case No.0034/2021 and ensure that not only the offending trawler, but the other trawlers and persons who connived and joined the offending trawler are traced and proceeded with under law. A status report may be filed by 23.03.2021 before this Hon'ble Court. Government of Odisha and Union of India may be directed to assist in tracking the offending trawlers by utilizing the available technology.
- c. Details of pending cases relating to illegal fishing in Gahirmath Sanctuary area, and a list of habitual offenders be provided by the Superintendent of Police, Kendraprara, so that the trial of those cases be directed to be expedited.
- d. The joint patrolling staff of the Forest Department and Marine police stations at Talchua, Tantiapal and Jamboo may be directed to use appropriate force/measures in case of life risk and self defence.
- e. The marine police stations may be provided with boats immediately and the damaged boat be repaired within a week.

I Sri Debasis Bhoi (29), S/o-Rushyananda Bhoi of village Champapur, PS-Byree, Dist-Jajpur A/P- Range officer Gahirmatha WI. Ronge do hereby lodge this report with effect that yesterday i.e. on dt.15.03.2021 at 08.15 PM our forester Sanjib Kumar Das along with constable/435 Bhnguan Tudu, constable/444 Timotius Burh at RO. Kendrapara, Fagala Marandi, Chanchala Maity (protection Sqd. Member), Babu Jena and Madhusudan Behera (Boat driver) were performing sea patrolling at Gahiramatha Marine Regd. No. Padmalaya bearing Sanctuary with patrolling Trawler namely INDOR01MM311. At about 10.30 PM one illegal fishing trawler namely "New Janani-1" was fishing inside the Gahiramatha Marine Sanctuary (spot i.e. N 20 39' 41.6", E 087' 13'26.8"). The patrolling parties tried to capture the said trawler coming closed to it but the said trawler's crew members attacked with a kitchen knife and axe with an intention to murder. As a result our boat driver namely Chanchala Maity sustained injury on his left leg so also three other members of patrolling parties namely Gyana Ranjan Swain, Jaga Das and Pradeep Mandal were sustained injury. The Illegal fishing trawler smashed back side of our patrolling boat and heavy damage. The crew members of said illegal trawler along with crew members of about 05 other illegal trawlers attempted kill patrolling parties by drowning our patrolling boat with an intention to murder in the deep sea. The accused persons obstructed our official duties and caused injury to our patrolling parties. Fortunately our patrolling parties managed to save their lives and back to nearby station (Babubali Island near to Wheeler Island).

Therefore I request you to take necessary legal action as per law against accused persons.

Assault of patrolling boat and staff by fishing boats in Gahirmatha marine wildlife sanctuary,

In inviting a reference to the above cited subject it is to bring to your kind notice that during patrolling in Gahirmatha marine sanctuary on 15.03.2021, the staff of Gahirmatha Wildlife Range along with the APR staff in the patrolling boat namely "Padmalaya" bearing Regd No. IND-OR-01-MM-311 provided by Dhamra Port (DPCL), at about 10.30PM detected one illegal fishing boat namely "NEW JANANI-I" inside the sanctuary (location N-20° 39' 41.6" E-087° 13' 26.8"). The patrolling staff tried to detain the said boat by approaching close to it but the crew members of the fishing boat attacked the staff and dashed the back of the patrolling boat with the fishing boat. As a result five members of patrolling staff including the driver sustained injury and back side body of the patrolling boat got damaged. The crew of fishing boat and five other fishing boats threatened the patrolling staff with ill intention. Fortunately the patrolling staff managed to escape back to Babubali patrolling camp. The Range Officer, Gahirmatha WL Range has lodged FIR in Talchua Marine Police Station on 16.03.2021, copy of the FIR is enclosed as Annexure-I.

The alleged fishing boat (gillnetter) is owned by one Makhan Mandal, S/O Nirinjan Mendal of Bhadrak District and got the boat registered at Dhamra fishing base vide registration no.IND-OR-01-MM-514. The said boat had been seized earlier on 14.10.2019 for fishing in Gahirmatha sanctuary and a case has been booked against the boat in 2(b)CC No. 69/19 arising out of OR Case no. 43G of 2019-20 of Gahirmatha WL Range. It was released to interim custody of the owner as per order Dated 22.01.2020 of the learned Sessions Judge. Kendrapada. The owner has also fuctished an undertaking not to violate the provisions and not to enter Gahirmatha sanctuary during interim custody. Copy of the said undertaking is furnished as Annexure-II.

From the record it is seen that the father and brother of Makhan Mandal also possess a number of fishing hoats. They are also habitual offenders as a number of cases have been booked against them for fishing in side Gahirmatha marine sanctuary. The detail of cases registered against boats of Niranjan Mandal and his other son Manas Mandal is furnished overleaf.
