
**AFFIDAVIT BY THE CHIEF DISTRICT

3. That, the present affidavit is being filed in compliance of the aforesaid directions of the Hon'ble Court.






4. That in reply to para No.2(i) of the Hon'ble Court's order dtd. 02.09.2021, it is humbly submitted that, estimates has been submitted by the Executive Engineer, R&B Division-II, Balasore to accord necessary administrative approval from Health and Family Welfare Department vide Letter No. 6501 dated 20/09/21. Copy of the letter dtd. 20.09.2021 is annexed herewith and marked as Annexure-A for kind perusal.. After receipt of the funds the same will be released to the Civil Contractors P.W.D. who have taken up the work of effecting repairs to the kachha houses in area-2.

Apart from that, it is also reported by the Executive Engineer, R&B Division-II, Balasore vide letter No. 6662 dt. 28.09.2021 that, the construction of shed at Leprosy colony is in progress. All the pile foundation for 10 nos. of dwelling houses have been completed. Brick work in 2 (two) nos. of dwelling houses have been completed up to lintel level & the balance work is in progress. Copy of letter No. 6662 dt. 28.09.2021 is annexed herewith and marked as Annexure-B for kind perusal.

5. That in reply to para No.2(ii) of the Hon'ble Court, it is humbly submitted that the filling up of the dump yard has been taken up by B.D.O Remuna, but it could not be completed due to incessant rain.. However, steps are being taken by the B.D.O. Remuna

to complete the earthen filling by the end of this week. Further, it is also submitted before the Hon'ble Court that, garbage has been cleaned up by BDO Remunā. Copy of the BDO Remuna, letter No. 2799 dated 27/09/21 is enclosed herewith and marked as **Annexure-C** for kind reference.

6. That in reply to para No.2(iii) of the Hon'ble Court, it is humbly submitted that as per the observation made by the Amicus Curiae(AC), a 2000 litre capacity overhead tank has been provided by the Executive Engineer, RWSS Division for uninterrupted water supply to the 10 toilets which have been constructed. Copy of photograph is annexed herewith and marked as **Annexure-D**.

In addition to this BDO Remuna has reported that, 6 Nos of toilets have been made fully functional with overhead Tank and water supply. 4 Nos of toilets are at finishing stage which will be completed shortly.

7. That the request by Hindu Kusth Nivaran Sangathan (HKNS) for increasing leprosy cases from 33 to 60 has been examined and accordingly, another 17 cured leprosy persons with deformities have been identified, thereby increasing the inmates from 33 to 50 have been proposed and their names have been submitted to the Secretary, Hindu Kusth Nivaran Sangathan (HKNS) for taking necessary action at their end. 


The filling up of dump yard inside the premises of the Leprosy Colony





