
9. The Court has also perused the affidavit of the Collector and District Magistrate, Khurda which inter alia indicates that four colonies i.e. the Bapuji Colony, Dharabati Colony, Jagannathpally Kustha


Colony and the Ramakrushnapalli Colony have in all 576 residents and 189 families a the total number of 129 CLPs. The affidavit mentions two persons one in the Jagannath Leprosy Colony and the other in the Ramakrushna Palli Colony as having been identified for skill development training. However, it is not clear why others have not been identified apart from these two. Likewise, the statement that there was no eligible CLP identified for self-employment training appears doubtful. A more concerted effort will perhaps have to be made by speaking to individual inmates, sensitizing them about the schemes and the opportunities available and encouraging them to opt for one or more of the schemes to improve their status in life.



Copy of the proceeding of the meeting held on 04.07.2022 is filed herewith and annexed as **Annexure —A**.


5. That, the Collector & District Magistrate, Khordha instructed the Project Director, DRDA, Khordha to form two Survey Teams to conduct door to door survey to counsel the individual inmates of the Colonies to cover under Skill Development Training and Self-Employment Training with an instruction to collect the application forms on the spot along with required documents from eligible Cured Leprosy Persons by 15.07.2022 positively.

Team-"A" has been assigned Jagannath Leprosy Colony, Rasulgarh, BBSR and Ramakrushnapalli Leprosy Colony, Kharavel Nagar, BBSR for survey. Like wise Team-"B" has been assigned Bapuji Leprosy Colony, Jatni and Dharabati Leprosy Colony, Jatni for survey.



Accordingly, the team members have visited four (04) Leprosy Colonies to counsel the individual inmates, sensitizing them about the Schemes and opportunities available for them. The Skill mapping of three Colonies namely Bapuji Leprosy Colony, Jatni, Dharabati Leprosy Colony, Jatni, Jagannath Leprosy Colony, Rasulgarh have been completed, but in case of Ramakrushnapally Leprosy Colony, Kharavel Nagar, Bhubaneswar survey is in progress and expected to be completed within next ten (10) days.

The survey has been completed for three (3) no. of Leprosy Colonies out of four (4) no. of Leprosy Colonies as detailed below.

Proceeding of 3rd Sub-Committee Meeting under the Technical Committee for formulation and implementation of rehabilitation Programme for Cured Leprosy

Persons and 3rd meeting in connection with implementation of "An Umbrella Scheme or Rehabilitation of Cured Leprosy Persons" in different Leprosy Colonies of Khordha district held on 04.07.2022 at 4.00 P.M. in connection with the direction of the Hon'ble High Court, Odisha on WP(C)-No.13403 of 2015,

The 3rd Sub-Committee Meeting under the Technical Committee for formulation and implementation of rehabilitation Programme for Cured Leprosy Persons and preparatory meeting in connection with implementation of "An Umbrella Scheme for Rehabilitation of Cured Leprosy Persons" in different Leprosy Colonies of Khordha district in order to implement the direction of the Hon'ble High Court, Odisha in WP(C) No.13403 of 2015 was held under the Chairmanship of the Collector & District Magistrate, Khordha on dated.04.07.2022 at 04.00 P.M in the Conference Hall of Collectorate, Khordha.

The members present at the meeting is annexed at Annexure-A.

The Collector & District Magistrate, Khordha asked the DSSO, Khordha to place the progress made till date on implementation of the scheme "An Umbrella Scheme for Rehabilitation of Cured Leprosy Persons" in different Leprosy Colonies of Khordha District in order to comply the orders of Hon'ble High Court on dated.18.05.2022.

After a detailed discussion, the following decisions were taken in the meeting as detailed below.

- 1. Survey & Identification: -A Survey has been conducted in 11 Leprosy Colonies of Khordha District. 352 families are enumerated in 11 Leprosy Colonies. Out of total population of 1089, 300 persons are identified as Cured Leprosy Persons.
- 2. Assistive devices: The District Leprosy Consultant assured that all eligible CLPs residing in 11 Leprosy Colonies have been provided with MCR Footwear Grade-I & MCR Foot wear Grade-II. He is instructed to submit the detailed list of CLPs who have been provided with MCR Footwear Garde-I & Grade-II with documentation duly certified by him and countersigned by the ADPHO, Khordha/ Bhubaneswar within 3 days that all the eligible CLP have been provided with Grade 1 and 2 foot wear.

(Action:- District Leprosy Consultant, Khordha)

DSSO, Khordha to supply 3 no. of Wheelchairs immediately to the eligible CLPs identified in BBSA Camps held at different Leprosy Colonies. Further, DSSO was instructed to contact Regional Manager, ALIMCO, BBSR to supply required indent of Aids & Appliances at an early date. Moreover, he is instructed to visit Advanced Rehabilitation Centre, BBSR to verify the status on supply of Orthotic & Prosthetic appliances within 2 days.

(Action:-DSSO, Khordha)

3. Assistance to Parents:- DEO, Khordha was instructed to depute two Teachers to each Leprosy Colony for identification of eligible Child Cured from Leprosy and Children of Cured Leprosy Persons filled up the applications there obtain signature of the beneficiaries in order to provide financial assistance to parents. PD DRDA to constitute a team for each Leprosy

(Action:- DEO, Khordha)

4. Pre & Post-Matric Scholarship:- Further the DEO, Khordha was instructed to depute two Teachers to each Leprosy Colony for identification of eligible Child Cured of Leprosy and Children of Cured Leprosy Persons for award of Pre & Post Matric Scholarship. The application form along with all requisite documents will be collected from the Child Cured of Leprosy and Children of Cured Leprosy Persons at the Leprosy Colony. The application form will be submitted to the concerned Head Master of the School where the child is studying for verification. Next the form will be submitted to the Deputy Commissioner (Welfare), BMC, BBSR/ BDO, Jatni/ E.O., Jatni Municipality & Khordha Municipality for signature of the concerned Authority. Then the form will be submitted to DSSO, Khordha for his countersignature and countersigned by the ADPHO, Khordha/ Bhubaneswar. After authentication of all the Officers, the Pre & Post Matric scholarship will be sanctioned against the Child Cured of Leprosy and Children of Cured Leprosy Persons. The CLPs who do not possess RFT Certificate, the ADPHO, Khordha/BBSR will provide RFT Certificates to them immediately after verification.

(Action:- DEO, Khordha/ DSSO, Khordha/ ADPHO, Khordha/BBSR)

5. Skill Development Training: -The DSSO, Khordha has reported that only 07 no. of CLPs have been identified as per survey for Skill Development Training. The Collector & District Magistrate, Khordha asked PD, DRDA to form a survey team in discussion with DSSO, Khordha. The team comprising of Officer from Social Security Section, one staff from ORMAS, one Trainer from RUDSET and one Trainer from Special ITI, Jatni will conduct door to door survey in 11 Leprosy Colonies and counsel them on Skill Development Training in different traders. The identified CLPs will be given Skill Development Training at RUDSET & Special ITI, Jatni & under the DDUGKY Scheme.

(Action:- DSSO, Khordha/ Director, RUDSET/ Principal, Special ITI, Jatni)

- 6. Self-Employment Kit:- The CDVO, Khordha was instructed to provide Self Employment Kit to the identified CLPs by deputing Veterinary Officers concerned to the Leprosy Colonies. DSSO, Khordha was instructed to obtain approval from the Govt. in SSEPD Deptt. (Action:- DSSO, Khordha/ CDVO, Khordha)
- 7. Self Help Group:- Mission Sakti staff will visit all the 11 Leprosy Colonies and counsel all CLPs to form Self Help Groups comprising of at least 5 CLPs in each Group and sensitize them about availing the Govt. Grant under different scheme & promotion of their livelihood.

(Action:-DSWO, Khordha)

8. Marriage Incentive & Support:- The DSSO, Khordha reported that no fresh eligible cases identified for Marriage Incentives during the survey but earlier two CLPs from Dharabati Leprosy Colony, Jatni were supported with Marriage Incentive for marriage of their daughters. He is instructed to sensitize CLP families about the Scheme.

(Action:- DSSO, Khordha)

9. Community Awareness:- Community Awareness and sensitization programme has been organized in all Leprosy Colonies by the District Administration.

10. Providing Medical Assistance: - The District Leprosy Consultant assured that Block Nodal Leprosy Worker(BNLW) along with Para Medical Workers are visiting all Leprosy Colonies and providing all Medical Assistance including dressing. One person from each Leprosy Colony has been trained to provide dressing to the CLPs as reported by the District Leprosy Consultant. The District Leprosy Consultant was instructed to submit a report on regular visit of the BNLW and Para Medical Workers to the Leprosy Colonies.

(Action:- DLC, Khordha)

11. Housing under Rural Housing Scheme:-The Collector & District Magistrate, Khordha instructed Deputy Commissioner, BMC, Executive Officer, Khordha/Jatni Municipality & BDO, Jatni to submit budget estimate for construction of new houses for CLPs in different Leprosy colonies. The budget estimates submitted, will be sent to the Govt. in Health & Family Welfare Deptt. for sanction of funds for construction new houses. DSSO, Khordha will ensure submission of the budget estimates by the above Officers.

(Action:- Deputy Commissioner (Welfare), BMC, BBSR/ BDO, Jatni/ E.O., Jatni Municipality & Khordha Municipality/ DSSO, Khordha)

12. Ration Card under NFSA Scheme:-Civil Supplies Officer, Khordha was instructed to include the only left out CLP under NFSA scheme immediately and submit a certificate" that all CLPs have been covered under NFSA scheme".

(Action:- CSO, Khordha)

- 13. Reconstructive Surgery:-DSSO, Khordha reported that as per survey no CLPs have been identified for Reconstructive Surgery during survey.
- 14. Coverage of CLPs under MBPY:-DSSO, Khordha reported that out of total 300 no. of CLPs, all eligible CLPs have already been covered under MBPY scheme and he is instructed to submit a certificate within 2 days in this regard.

(Action:-DSSO, Khordha)

- 15. Physiotherapy:- The DSSO, Khordha reported that as per survey no CLPs has been identified for Physiotherapy.
- 16. Provision on issue of Pattas to the CLPs:- The Collector & District Magistrate, Khordha emphasized on issue of Pattas to the CLPs residing in Govt. Land and asked ADM, Khordha to co-ordinate the matter.
