



3. That, it is pertinent to mention here that <u>Govt. of</u> <u>India does not sanction fund against each activity/</u> <u>component</u> under National Leprosy Eradication Programme (NLEP). Fund is sanctioned for each programme as one pool fund which is to be spent based on the approved budget against each activity. So it is not possible to provide the activity/component wise sanctioned amount under NLEP.

Similarly, <u>Govt. of India does not release the</u> <u>funds activity wise under NLEP</u> rather it is released as a common pool fund. So it is not possible to provide the activity/component wise fund release under NLEP.

In the years, the percentage of expenditure is below expectation due to clubbing and deferment of LCDC Campaign and other activities due to pandemic. In all those years, there is no compromise in the treatment and training aspects of the NLEP programme. In the year 2022-23 the provisional expenditure is 96%.
