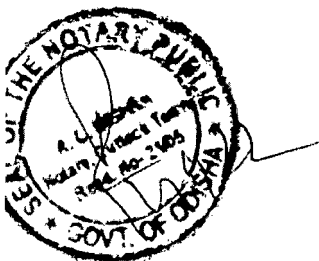
**AFFIDAVIT ON BEHALF OF COLLECTOR &

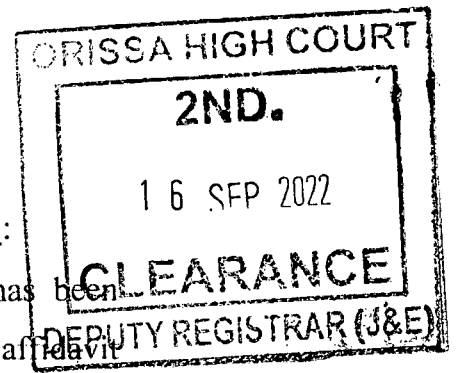
Coloured photographs of the ongoing construction of the twenty (8 + 12) are filed herewith and annexed as Annexure – A Series.
