


- I, Sri Tarun Tapan Praharaj, aged about 55 years, Son of late Pratap Chandra Praharaj, at present working as District Social Security Officer, Balasore, At/P.O./Dist.: Balasore, do hereby solemnly affirm and state as follows:
- 1. That, I am working as District Social Security Officer, Balasore and have been duly authorized by the Collector, Balasore to swear this Affidavit for and on his behalf.
- 2. That, the following steps have been taken with regard to the Lewis Leprosy Colony, Bampada. The electricity connection to 2<sup>nd</sup> phase building comprising eight quarters has been provided and occupied by 8 (eight) families.

Photographs showing 2<sup>nd</sup> phase building occupied by the 8 (eight) families are filed herewith and annexed as **Annexure – A Series**.

3. That, the Asst. Director of Textiles, Balasore Vide letter No.882 dtd. 13.04.2023 informed that four Looms were hired for the purpose of training of twenty (20) CLPs. After the completion of the training the Looms were returned. It has been further informed that steps are being taken to provide permanent looms to these trainees for earning their livelihood. For this purpose, twenty (20) Online applications from these CLPs have been received. They will be provided looms after the same is sanctioned by the Govt. and purchase thereafter. The entire process will take at least six (6) months time. At present, there is no CLP for training.

Copy of the letter No.882 dtd. 13.04.2023 is filed herewith and annexed as  $\underline{\mathbf{Annexure}} - \underline{\mathbf{B}}$ .

4. That, with regard to the issue of reconstructive surgery, the Addl. Dist. Public Health Officer, Balasore has informed that in Balasore district, the reconstructive surgery facilities are being provided to the leprosy patients in need. Presently there is no case fit to undergo reconstructive surgery in the Leprosy Colonies of Balasore district. However, one Sri Ajay Jena, Vill-Putina, PS-Kamarda, Block-Bhogari, Dist-Balasore who



required reconstructive surgery has successfully been operated and discharged on 10.04.2013 from Leprosy Home & Hospital, Cuttack.

5. That, the facts stated above are true to the best of my knowledge and based on available Official records.

We activated 4 nos. of Loom on hiring basis from the different weavers on Basic Weaving Training at Lewis Leprosy Colony, Bampada, Balasore. After the completion of the training the Looms returned to the concerned beneficiaries. So now the supply of Looms for engagement of their day to day life the following steps are being taken.

Now 20nos of application has been receieved from the beneficiaries of Leprosy Colony, Bampada, Balasore towards availing assistance for Loom with Accessories under promotion of Handloom Industries scheme.

The concerned staff has been instructed for field verification & submit the report as soon as possible.

Accordingly after receiving the verification report it will be submitted for District Level Monitoring Committee (DLMC) meeting under the Chairmanship of Collecter & District Magistrate, Balasore.

Then the DLMC proceeding & list of the beneficiaries will be submitted to the Director Of Textiles, Odisha Bhubaneswar for approval & sanction.

After sanction of funds from the Govt. Of Odisha quotation will be invited from different supplier parties to participate in the purchase committee meeting with their samples.

The purchase committee will select among the supplier whose sample is qualitative & less price than the other.

Then the supply order will be placed to the supplier, selected to the supply the items.

Then only the items will be Distributed among the beneficiaries in the presence of the field staffs.

Maximum six months are required to covered them under the scheme.
