

"xxx XXX XXX 4. On the issue of reconstructive surgery, certain details have been set out in the affidavit of Mr. Mohanty in a tabular form. It indicates that although some reconstructive surgeries have been conducted, many more patients remain to be provided such treatment. The Court directs that the Monitoring Committee (MC)appointed by it will take up this issue immediately and ensure that under the directions issued by the MC, all the patients awaiting reconstructive surgery will be given that benefit in a timebound manner and positively within a period of three months from today. Further, the issue regarding the rehabilitation of the inmates of Sanjay Leprosy Colony, Puri as pointed out in the convenience of the learned AC will also be taken up by the MC committee.



That, with regard to the directions contained in <u>Paragraph – 4</u>, the matter was reviewed in the meeting of the Monitoring Committee held on 22.04.2023 and it was observed that for Reconstructive Surgery (RCS), patients are examined for eligibility of surgery and are admitted in the Hospital for all routine examinations like Diabetics, Cardiac,

PRADIPTA KUNDA MOMANTI Notary, Guilleck Town Rend. No- ON-04/1995 Kidney, Liver diseases, Hemoglobin, HIV, Complete Blood Count etc. and if found fit by the concerned surgeon, then they go for the Reconstructive Surgery.

- i. The stay in hospital for RCS is around 45 60 days including pre &post operative care & physiotherapy.
- Due to various constraints and family problems, some patients are not willing to undergo surgery but they are repeatedly counselled by Accredited Social Health Activist (ASHA), Health Workers and Medical Officers to undergo Reconstructive Surgery.
- iii. For better accessibility of patients, provisions have been made to conduct RCS in all District Head Quarter Hospitals (DHH) .(Annexure-A)
- iv. During the current Financial year (2022-23), 179 (One Hundred Seventy-Nine) Reconstructive Surgeries have been conducted in 27 districts as reported by districts Out of 97 pending cases for RCS in 2022-23:
 - 21 cases are medically unfit for other comorbid conditions.
 - In 59 cases patients unwilling for Surgery.
 - 17 cases have been migrated to other places.

With regard to rehabilitation of inmates of Sanjay Leprosy Colony, Puri, a door-to-door survey was conducted by the Puri District Administration. After the survey, it was revealed that out of the 21 families consisting of 41 members living in the colony. Out of this 21 families, 13 families

consisting of 14 members have already been rehabilitated in Niladri Nilaya Rehabilitation Centre (Special Rehabilated Center for cured leprosy patients) at Puri Municipality. The District Administration is in the process to rehabilitate the remaining eight (8) families consisting of 27 members.

4. That, this Hon'ble Court Vide Order dtd. 20.03.2023 in Paragraph – 6 directed as follows:

"xxx xx xxx xxx xxx 6. It is directed that the next meeting of the MC will be held on22nd April, 2023 at 3 pm to enable the ACs to attend the meeting. The Convener of the MC will inform the other members sufficiently in advance to ensure that they are present at the said meeting. The minutes of the above meeting of the MC be placed on record of the Court on the next date. It is directed that the MC committee should meet at least once in two months.

- 1) Rs. 8000/- (Rupees eight thousand) is provided to the patient in phases for loss of wages per RCS for undergoing surgery (FMR. 1.2.3.1, Sl. No. 70).
- 2) Rs. 1500/- (Rupees fifteen thousand) is provided to the patient for to & fro journey per RCS to the health institution for RCS (FMR. FMR. 1.2.3.1, SI. No. 70).
- 3) Mobility and other support to the RCS surgeon (FMR. SI.No-86).
- 4) Mobility & other contingency support for hands on training to Doctors (Surgeon/ Orthopedic Specialist/ Plastic surgeon) assisting the RCS Surgeon. (FMR. 9.5.13.1, Sl. No. 72).
- 5) Rs,5000/- (Rupees five thousand) for medicines & consumables for the medicines and consumables not available in the hospital per RCS.(FMR.9.5.13.1 SI.No.70)
- 6) Rs. 500 /- (Rupees five hundred) as incentive to the ASHA for motivating the eligible G2D leprosy patient and completeing the surgery. (SI. No. 72 (New Activity).



other districts for Reconstructive Surgery which is demotivating the patients for RCS. There are also coordination problems when a patient is referred from one district to another district.

The district NLEP unit / ADPHO (Leprosy) will intimate the number of eligible and willing patients to undergo Reconstructive surgery and the date to State NLEP unit for coordinating with RCS surgeon. Preferably a specialist in surgery/ Orthopaedics/ Plastic Surgery of the same district to be directed for hands on training in assisting the RCS Surgeon and do the post operatiive care of the patient after surgery.

It is therefore requested that henceforth Reconstructive Surgery will be conducted in all district Head Quarter Hospitals, PGIMR & Capital Hospital, Bhubaneswar and RGH Rourkela and indoor beds will be provided to the RCS patients during pre & post operative period for successful implementation of NLEP activities and for the benefit of the patients.

MINUTES OF 5th MEETING OF THE MONITORING COMMITTEE

12 -

The 5th Meeting of the Monitoring Committee was held on 22.04.2023 at 3.00 PM. Commissioner-cum-Secretary, SSEPD Department, Health & Family Welfare Department, Members of the Committee, and Officers of SSEPD and H&FW Department were present in the meeting.

Commissioner-cum-Secretary, SSEPD Department – cum - Convener of the Committee made a brief presentation on the orders Dt. 20.03.2023 of Hon'ble High Court of Orissa in WP (C) No.13403/2015 (Bipin Bihari Pradhan Vrs State and others), and requested H&FW Department to present the status of reconstructive surgery (RCS) in the State. He informed the committee that 276 cured leprosy persons have been identified for reconstructive surgery in the FY 2022-23 and out of which 179 persons have undergone reconstructive surgeries. The remaining 97 cases could not be operated due to following reasons:

i. 21 cases are medically unfit for RCS for other comorbid conditions.

ii. In 59 cases persons are unwilling for surgery.

iii. 17 cases have migrated to other places.

District-wise data on surgery is placed at Annexure-A. He also informed the committee about the incentives provided by H&FW Department to the individuals opting for reconstructive surgery and the steps taken for hassle-free surgery on the individuals.

 For strengthening of RCS centres, provisions have been made in Programme Implementation Plan 2022-23 for procurement of additional instruments & equipment for Reconstructive Surgery (RCS) in 11 (eleven) Districts & Leprosy Home & Hospital i.e., Bargarh, Bolangir, Boudh, Dhenkanal, Ganjam, Mayurbhanj, Nawarangpur, Nuapada, Sonepur, Sambalpur, Jharsuguda districts and Leprosy TRUE COPMAT Home & Hospital at Cuttack.

 Provisions have been made to conduct RCS in all District Head Quarter Hospitals (30 DHHs & Capital Hospital, Bhubaneswar) for better accessibility for the patients.

- 3. RCS is also covered under Biju Swasthya Kalyan Yojana (BSKY) so that patients can avail the treatment in all empaneled private Health institutions.
- 4. To recoup the wage loss of the patients due to RCS, Rs. 12,000 as one-time assistance, Rs. 1,500 as transportation cost and Rs. 5,000 towards additional medicine/ consumables are provided to them.
- 5. Incentives of Rs. 500 are being paid to ASHA Workers for motivating the eligible G2D cases for RCS.

Director (Public Health) reiterated that steps are being taken to clear the backlog reconstructive surgeries under NLEP within three months and letter in this connection has already been issued to all CDM & P.H.O vide letter No.2127 dt.03.04.2023 of the Directorate of Public Health (State Leprosy Cell). He also informed the committee that there are 381 Integrated Disability Prevention & Medical Rehabilitation (DPMR) (32 DHH +33 SDH+314 CHC + Urban) functioning in the State providing free services in all cases of disability.

Participating in the discussion Shri B.P. Tripathy, Advocate and learned Amicus Curiae suggested that the activities of DPMR Clinics need to be monitored. He informed the Committee that he had personally visited two CHCs in Khordha and Puri, and observed that adequate facilities were not available for Leprosy patients. Commissioner-cum-Secretary, H&FW Department requested him to share the details of the CHCs and informed the Committee that a wider monitoring of all DPMRs will be taken up very soon.

DSSO, Puri explained the Committee on the status of rehabilitation of the inmates of the Sanjayjee Leprosy Colony, Puri.

Ms Pami Rath, Advocate and learned Amicus Curiae enquired about the living condition and livelihood status of the inmates rehabilitated at Niladri Nilaya Rehabilitation Centre. TRUE COPY ATTESTED

He informed that they have conducted a survey in the colony and identified 21 families with one or more individual CLP in each family. Out of these 21 families consisting of 41 individuals, District Administration has already rehabilitated 13 families consisting of 14 members in Niladri Nilaya Rehabilitation Centre (Special Rehabilitation Center for cured Leprosy Persons) at Puri Municipality. Niladri Nilaya has been developed by Puri Municipality with an estimated cost of Rs.42,50,715/- in the year 2021. At Niladri Nilaya Rehabilitation Centre they are provided free accommodation with beddings including blanket and mosquito net, accessible toilet facilities, safe drinking water etc. Further, fooding and other daily requirements are being provided to them. Monthly health checkup of inmates is being conducted by doctors and para medical staff regularly and medicines are provided free of cost. All 14 members of these 13 families are covered under Madhubabu Pension Yojana, provided aids and appliances e.g., wheel chairs, tricycles and crutches. During the pandemic period COVID 9 eligible women out of these inmates have been provided Rs.10,000/- each under the scheme "Mission Maa". However, due to ageing and deformity, it is not possible to cover them under any livelihood programme. But, only two women are preparing cotton balita for worship purpose.

The District Administration, Puri also identified a patch of land adjacent to Niladri Nilaya Rehabilitation Centre in Puri Municipality under Government khata No.149,plot No.355,333,349,353,359,249/498,294,295,299,299/505, 292,296/506,295/499 having area in AC. 0.7280,0.1040, 0.6500,0.1550, 0.3770,0.0500,0.3400,0.5150,0.1740, 0.0400,0.9000, 0.0200,0.0450 of Mouza Lokanath Ghat under kisam Bagayat-II, Rasta, Jalashaya-II, Patita, Gharabari-I and Nadia Bagayat with possession note in the remark column as "Kosthashram" for rehabilitation of remaining 8 families consisting of 27 members. Estimate for Rs.1,19,01,500/- has already been prepared with the help of R & B for construction of house for these 8 families. Commissioner-cum-Secretary advised to submit the estimate immediately to H & UD Department to cover them under urban housing Scheme/ Jaga Mission. These families have already been covered under Madhubabu Pension Yojana, provided aids and appliances e.g., tri-cycles and other assistive devices as per requirement. Ration cards have also been provided to these families under NFSA. Further, one SHG group with 5 members have been formed and financial assistance of Rs.10,000/- have been provided. 8 eligible women out of these 8 TRUE COPY ALLESTED provided financial assistance @ Rs.10,000/- each under scheme "Mission Maa" and 4 eligible students of these families have provided scholarship.
