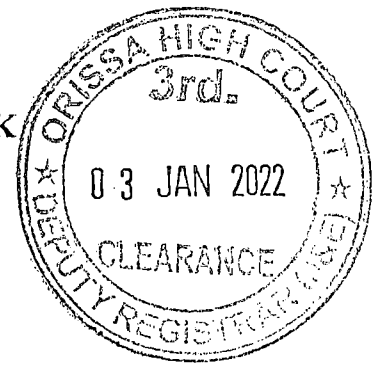

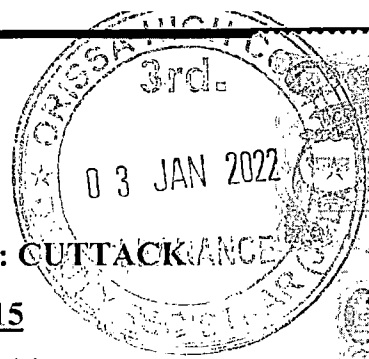

AFFIDAVIT BY THE COLLECTOR, BALASORE  
IN COMPLIANCE OF ORDER DTD.30.11.2021:

I, Sri K. Sudarshan Chakravathy, IAS, aged about 40 years, Son of K. Seetha Rama Raju, at present working as Collector, Balasore, At/P.O./Dist.-Balasore, do hereby solemnly affirm and state as follows:

1. That, I am the Collector, Balasore and well acquainted with the facts of the present case.
2. That, I have gone through the contents of the Order dtd.30.11.2021. Paragraphs- 9 to 12 of the Order dtd.30.11.2021 are extracted hereunder for convenience:

“xxx

9. So far as the Lewis Leprosy Colony, Balasore is concerned, the report of the Amicus Curiae points out that the inhabitants are not getting raw diets, which includes rice, dal, edible oil etc. and that possibly not paid to the local contractors for supply of raw foods to the inmates.

10. A direction is issued to the Collector, Balasore to immediately ensure supply of raw food will not be stopped whatsoever. He will

also sort out the issue concerning the engagement of local contractors.

11. It is pointed out that steps have been taken to construct ten houses and construction work for other thirteen houses is going on. On scrutiny of the photographs, a direction is also issued to construct the remaining thirty houses and to commence this construction forthwith.

12. Next compliance affidavit by the Collector, Balasore will be filed indicating specifically the construction of additional houses.

3. That, regarding compliance of the directions contained in Paragraphs-9 & 10 of the Order dtd.30.11.2021, it is submitted that all the inhabitants of the Lewis Leprosy Colony, Balasore are getting raw diets which includes rice, dal, edible oil etc.

As regards payment of local Contractors for supply of diets the Manager S.B.I Motiganj Branch Balasore has been requested by the District Public Health Officer, Balasore Vide letter No.20588, dtd.15.12.2021 to transfer the fund of Rs.8,22,174/- (Rupees eight lacs twenty two thousand one hundred seventy five) only to the A/C No. 30195741419 of Sri Subrat Kar. As regards, engagement of a diet, tender was floated and one M/s. S.K. Enterprisers, Balasore has been selected. Work Order has been issued Vide letter No. 20919, dtd.20.12.2021 for supply of diet to the THW & RC inmates of Bampada.

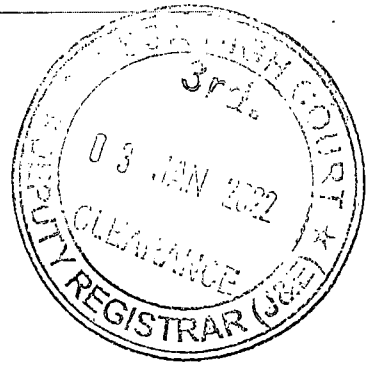

4. That, regarding compliance of the directions contained in Paragraphs-11&12 of the Order dtd.30.11.2021, it is submitted that four (4) nos. of existing old & damaged houses at Bampada were dismantled and the RCC roof building consisting of eight (8) nos. of houses have been taken up at that place. Presently the piling work for foundation work is in progress and completed up to 80% as reported by the Superintending Engineer, Balasore (R & B), Division-II Vide letter No.9259, dated 22.12.2021.

Further it is intimated that 10nos. of houses have been completed and handed over to 10nos. of inmates. Presently, eight (08)nos. of houses are under construction and will be completed within three months. Estimates for construction of another twelve (12) houses have been prepared and work will be taken up immediately after finalization of the tender process. So far as the rest three (03) houses (out of the total of 33 inhabitants) are concerned, it is submitted that three inmates are couple and living together for which 30 houses are required.
