He / She is appointed temporarily to officiate as Junior Stenographer in the Court's Establishment in the Scale of Pay of Rs. 25,500 - 81,100/- with usual allowances as sanctioned by the State Government from time to time. The appointment is purely temporary and is terminable at any time without assigning any reason whatsoever. He / She should join his / her new assignment on **01.06.2022** failing which the appointment shall be treated as cancelled.

He/ She should furnish the following documents at the time of joining;

- (i) "Attestation Form" in duplicate duly filled in alongwith two passport size photographs attested by a Gazetted Officer.
- (ii) Medical Certificate of fitness from a Medical practitioner not below the rank of Assistant Surgeon.

- (iii) Two Character Certificates from two Gazetted Officers.
- (iv) Declaration to the effect that he / she has not been dismissed from any Govt. Service.
- (v) Declaration to the effect that he / she has not more than one spouse living in case he / she is married.
- (vi) Undertaking to the effect that he / she agrees and is prepared to duly discharge the duties assigned to him / her by the Court in course of his / her posting.
- (vii) Certificate and Mark Sheets in support of date of birth, caste, educational qualification, technical qualification etc., in original alongwith their copies duly attested by a Gazetted Officer .

The appointment is subject to verification of all the certificates along with his / her character and antecedents in the manner prescribed by the government. In case his / her certificates, character and antecedents are not found correct / satisfactory, he / she will be removed from government service immediately without any notice.

No T.A./D.A. will be allowed to join the post.


