5. Declaration to the effect that he/she has not more than one spouse living in case he/she is married.
6. Undertaking to the effect that he/she agrees and is prepared to duly discharge the duties assigned to him/her by the Court in course of his/her posting.
7. Certificates and Mark sheets in support of date of birth, caste, educational qualification, technical qualification etc. in original along with their copies duly attested by a Gazetted Officer.
