CANCELLATION OF MAIN WRITTEN EXAMINATION CONDUCTED ON 13.07.2025 W.R.T. "RECRUITMENT TO THE POSTS OF ASSISTANT SECTION OFFICER" PURSUANT TO ADVERTISEMENT NO. 02/2024

In pursuance of Advertisement No. 02/2024, the Main Written Examination was conducted on 13.07.2025 in respect of the 7,113 candidates who qualified the Preliminary Examination. Since, the Court entertains serious doubts in the conduct of Main Written Examination by the Agency engaged for the said purpose, the Court has decided to cancel the same which was held on 13.07.2025 in order to ensure fairness in the examination process.
