NOTICE OF TENDER FOR SUPPLY OF TWO NUMBERS OF SCANNERS, TWO NUMBERS OF EXTRA MONITORS WITH CONVERTER CABLE AND TWO NUMBERS OF UPS

High Court of Orissa, Cuttack invites price quotations addressed to The Registrar (Judicial) in the sealed envelope for supply, installation, testing and maintenance of two numbers of scanners with five year warranty period, two numbers of extra monitor having three year warranty period with converter cable and two numbers of UPS (600 VA) having one year warranty period with the following terms and conditions:

1. Delivery, Installation and Testing of aforesaid hardware items are required to be made at the High Court of Orissa **on or before 10th December, 2021**. No request for extension shall be allowed. The participating bidder shall remain prepared to deliver, install and test all the hardware items within time specified above.
2. The bidder must provide all necessary warranty services for the supplied hardware items till expiry of warranty period.
3. The replacement of any part of any hardware item whenever required within the warranty period must be carried out with new, standard and genuine parts.
4. In case where the supplied hardware item becomes unserviceable and non-repairable during the warranty period, the successful bidder must replace the same with new scanner of same specification.
5. Every participating bidder must submit declaration
6. The Court can terminate the work order or purchase order if the firms fails to carry out any of its obligations / duties in terms of the contract.
7. Price quotations should be submitted only by hand or registered post addressed to the Registrar (Judicial), High Court of Orissa, Cuttack. Quotations received after last date and time of submission shall not be considered.
8. Important Dates/ Time-
 - a. Start date: **06.12.2021**;
 - b. Last Date of submission of price quotations: **08.12.2021 till 05.00 PM**;
 - c. Date and Time for opening of price quotations: **09.12.2021 at 11.30 AM**.
9. The Scanners must meet the specifications mentioned in **Annexure- A** and extra monitor must having the minimum specification of screen size-19 inch, at least one HDMI port or one Display port and three year warranty period alongwith converter

cable and two numbers of UPS having battery capacity of 600VA and one year warranty period.

10. **Every bidder must submit Self Declaration in the format at Annexure-B.**

11. Authorized representatives of the bidders may remain present at 11.00 AM on 09.12.2021 for witnessing the opening of price quotations.

12. The Court shall take into consideration eligibility of a bidder while considering the price quotation.

13. The price quotation of ineligible bidders shall not be considered.

14. High Court of Orissa reserves the right to amend or withdraw any of the terms and conditions mentioned as above or to reject any or all tenders without giving any notice or assigning any reason thereof.
