CONTRACT OF 115 NUMBERS OF HP LAPTOPS SUPPLIED TO THE JUDICIAL

High Court of Orissa, Cuttack invites bids from reputed, experienced and financially sound Companies/Firms/Agencies for providing Comprehensive Annual Maintenance Contract for 115 numbers of HP Laptops supplied to the Judicial Officers across the State. Those who are in the relevant business for the last three years and at present providing service/maintenance of Laptops to Central/State Govt. Department, PSUs, Autonomous Bodies, Large Industrial/Educational Campus/corporate Super Specialty Hospitals, High Courts of other States and capable of providing such services at present, may upload their bids both Technical and Financial in the e-Procurement portals in .pdf and .xlsx formats respectively. Complete Tender Document may be obtained from the e-Procurement portal of the Government of Odisha <http://tenderodisha.gov.in> starting from **22.03.2022** to **13.04.2022**, by uploading the bid documents (Technical) along with copy of Demand Draft of **Rs.1,000/- (Non-Refundable)** towards **Tender Fee**. The format of the bid document and the necessary Annexures can also be downloaded from the e-Procurement Portal of the Government of Odisha. The bidders using the tender form downloaded from the website shall enclose one scanned copy of Demand Draft of **Rs.1,000/- (Non-Refundable)** towards Tender fee payable at Cuttack and drawn in favour of “**Registrar (Judicial), High Court of Orissa**” on or before **13.04.2022** online and the Original Demand Draft is to be deposited in a sealed envelope at the Computer Section, High Court of Orissa on or before **13.04.2022** in offline mode. The envelopes should be duly super-scribed as “*Tender fee for the e-Tender invited for Comprehensive Annual Maintenance Contract of 115 nos. of HP laptops supplied to the Judicial Officers across the State.*”

NOTE: The Demand draft for Tender Fee should be submitted offline failing which the bid shall be rejected forthwith.

The sealed envelope is to be deposited in the Computer Section, High Court of Orissa Premises or may be sent through registered/speed post addressed to “**The Registrar (Judicial), High Court of Orissa, Chandinichowk, Cuttack, PIN- 753002**”.

Bids will be opened on **18/04/2022 at 03.30 PM** in the presence of bidders or their authorized representatives who wish to participate in the bidding process.

Any future clarification(s) and / or corrigendum shall be communicated by order of Registrar (Judicial) only through the e-Procurement portal. Hence, bidders are advised to always check the e-procurement portal of the State Government.

High Court of Orissa, Cuttack reserves the right to amend or withdraw any of the terms and conditions contained in the Tender Document including information concerned with type of service and any other services (if any), to be provided or to reject any or all tenders without giving any notice or assigning any reason thereof.
